## Position Description

<b>Title of Position:</b>	Viticulturist/Senior Viticulturist
<b>Reporting to:</b>	Group Manager – Industry Development and Support
<b>Overview:</b>	The Viticulturist/Senior Viticulturist contributes to the quality and integrity of Australian wine through development and presentation of knowledge to grape and wine industry personnel.
<b>Qualifications:</b>	A degree in viticulture or a related discipline, with a postgraduate qualification preferred.
<b>Experience:</b>	At least five years' practical experience of grapegrowing and production practices.

### Principal Accountabilities:

1. Play a key role in the delivery of the AWRI's greater viticulture capability, which is aimed at the dissemination of knowledge and information to the grape and wine sector. This can include, but is not limited to technical support, extension, biosecurity, sustainability, and regulatory activities.
2. Conduct and manage viticultural extension and communication projects.
3. Develop material for and participate in seminars and other extension and communication activities.
4. Promptly respond to enquiries received through the AWRI helpdesk regarding viticultural practices, pest and disease control methodologies and regulatory matters.
5. Conduct helpdesk investigations into technical problems encountered by Australian grape and wine producers.
6. Provide advice and direction to the grape production sector when required and contribute to the AWRI's response to specific grape or wine sector emergencies as they arise.
7. Advise on and contribute to viticultural activities throughout the AWRI.
8. Undertake and manage commercial projects as required and meet financial objectives.
9. Organise and supervise ancillary staff contracted to provide specialist training and extension services to the grape production sector.
