**OFF-LABEL PERMIT (OLP)**  
**FOR USE OF A REGISTERED AGVET CHEMICAL PRODUCT**

**PERMIT NUMBER - PER5571**

This permit is issued under the Agvet Code, of the relevant jurisdictions, to the person stated above. The holder of the permit must comply with all requirements as specified in the Agvet Code. A summary of the key requirements are that the holder must:

- supply any requested information to the NRA;
- inform the NRA if they become aware of any relevant information concerning the uses dealt with by this permit; and
- comply with a lawful direction or requirement of an inspector.

This permit for the reason given below, allows any person listed in **1. Persons** to use the products listed in **2. Products** for the minor off-label use specified in **3. Directions for Use** in the jurisdictions listed in **4. States**.

If this permit were not issued use of the products as specified in this permit would constitute an offence under the Agvet Codes.

The persons listed in **1. Persons** must comply with all conditions listed in **CONDITIONS OF PERMIT** to be effectively covered by this permit.

**THIS PERMIT IS IN FORCE FROM 1 NOVEMBER 2002 TO 1 NOVEMBER 2003.**  
**It is in force until it expires or it is cancelled, suspended or surrendered.**

**Reason for issue of permit:**

Garden weevil is a major pest in Western Australian grapevines. Adults attack the developing bunches and vegetative growth during spring and early summer, these attacks can result in yield losses as high as 10 percent. There are no other products currently registered for the control of Garden weevil in bearing vines in Western Australia. This is a renewal of a previously issued NRA permits PER1359 and PER3578.

## **DETAILS OF PERMIT**

SUMITOMO SUMI-ALPHA 19EC INSECTICIDE

Containing: 19 g/L ESFENVALERATE as its only active constituent.

HALLMARK 50 EC INSECTICIDE

SUMITOMO SUMI-ALPHA 50EC INSECTICIDE

Containing: 50 g/L ESFENVALERATE as their only active constituent.

### **3. Directions for Use**

<b>Crop</b>	<b>Pest</b>	<b>Rate</b>
BEARING GRAPEVINES	GARDEN WEEVIL	<b>Products containing 19g/L esfenvalerate:</b> apply at a rate of 80 mL product per 100 L water. <b>Products containing 50g/L esfenvalerate:</b> apply at a rate of 30mL product per 100L water.

#### **Critical Use Comments:**

Apply after peak weevil emergence in late spring but before damage.

Apply at least 500 litres of solution per hectare at night.

A second application 2-4 weeks later may be required.

Use of this product may cause outbreak of secondary pests.

DO NOT apply more than 2 applications per season.

#### **Withholding Period:**

DO NOT APPLY LATER THAN 28 DAYS BEFORE HARVEST.

#### **USERS**
