**Product to be used:**

**FARMOZ AXIOM MZ 720 SYSTEMIC & PROTECTIVE FUNGICIDE**  
Containing: 640.00 g/kg MANCOZEB  
80.00 g/kg METALAXYL as the only active constituents.

**Directions for Use:**

Grapevines	Downy Mildew ( <i>Plasmopara viticola</i> )	250g/100L

**Critical Use Comments:**

Apply by dilute or concentrate spraying equipment. Apply the same amount of product to the target crop whether applying this product by dilute or concentrate spraying methods.

This use is subject to an AVCARE anti-resistance strategy. When conditions favour Downy Mildew development (prolonged humid wet conditions) apply two consecutive sprays at 7 to 21 day intervals. Apply as soon as possible after the infection period. DO NOT apply more than two consecutive sprays of a group D product. Resume the program of protectant sprays.

Minor phytotoxic reactions on some varieties of grapes may occur under certain conditions.

Dilute Spraying: Apply to the point of runoff. Use a minimum of 500L mixture per hectare before flowering, increasing volume to a minimum of 1000L per hectare when vines are in full foliage.

Concentrate Spraying: Use a minimum of 125L mixture per hectare before flowering, increasing volume to a minimum of 250L per hectare when vines are in full foliage.

**Withholding Period:**

DO NOT HARVEST FOR 14 DAYS AFTER APPLICATION

**Jurisdiction:**

NSW, SA, WA only

**(Note: Victoria is not included in this permit because their 'control-of-use' legislation means that a permit is not required to legalise this off-label use in VIC).**

**Additional Conditions:**

THIS PERMIT provides for the use of a product in a manner other than specified on the approved label of the product. Unless otherwise stated in this permit, the use of the product must be in accordance with instructions on its label.

PERSONS who wish to prepare for use and/or use products for the purposes specified in this permit must read, or have read to them, the details and conditions of this permit.

**TO AVOID CROP DAMAGE:**

The sensitivity of some species and varieties of the crops to be treated under this permit has not been fully evaluated. It is advisable, therefore, to only treat a small number of plants to ascertain their reaction before treating the whole crop.
